1 Information about the documentation

1.1 About this documentation

- Read this documentation before initial operation or use. This is a prerequisite for safe, trouble-free handling and use of the product.

2 Safety


2.1 Additional safety instructions, detectors

 This product complies with all the requirements of the applicable directives, but **Hilti** cannot entirely rule out the possibility of interference caused by powerful magnetic or electromagnetic fields affecting it, possibly leading to incorrect measurements. Check accuracy by taking measurements by other means when working under such conditions, or if you are unsure.

- ▶ Before operating the device, read the operating instructions stored in its memory.
- ▶ Use the product only when it is in perfect working order.
- ▶ Never tamper with or modify the product in any way.
- ▶ Do not operate the scanning tool in explosive atmospheres, such as in the presence of flammable liquids, gases or dust.
 - ↳ Sparks that can ignite dust, fumes or vapors can be created in the scanning tool.
- ▶ Acclimatize the scanning tool before using it.
 - ↳ Big differences in temperature can lead to incorrect operation.
- ▶ Always check the device settings before using it.
- ▶ After switching on, observe the display.
 - ↳ A disclaimer appears when the device powers up. You must accept this disclaimer in order to access the main menu.

- ▶ Keep the display clean and carefully dry the device before stowing it in a transport container.
- ▶ Keep to the specified range of operating and storage temperatures between -25 °C and +63 °C.
- ▶ Remove the battery prior to storage.

3 Description

3.1 Product

3.2 Use

The tablet is designed to be used to display and analyses scans made with **Hilti Scan** systems. Scans can be managed in projects and subsequently transferred to a PC for data evaluation and archival.

5 Before use

5.1 Charging and switching on

1. Charge the device fully.
2. Switch the device on by pressing the on/off button.
3. Start the PSA 200 application.
4. Before the PSA 200 application can be used you must accept the terms of the disclaimer notice displayed.
5. Press the **X** symbol at top right to end the PSA 200 application.

- To switch the device off select **Start** → **Shut down**.

5.2 Activation

- Type the activation key and your contact data.



When starting the PSA 200 application for the first time you will be required to enter your contact data and the activation key.

- Confirm your entries by pressing the **Activate** function button.



The PSA 200 application cannot be used unless your contact data and a valid activation key have been entered.

5.3 Settings

- Select the desired language, the desired country and the units you wish to be displayed.



When operating a brand new device you will first be requested to select the country-specific settings.

- Confirm the settings you have made by pressing the **OK** function button.



By pressing **Skip** you can postpone making these settings until the next time the PSA 200 application is started.

6 Operation

6.1 Displaying the operating instructions

- Press the **?** symbol at top right.



The operating instructions will be shown in the right context in the display. You can then browse through the complete operating instructions.

- To close the operating instructions, press the **Back** function button.

6.2 Main menu

The PSA 200 application starts with the main menu, which can also be accessed at any time by pressing the **Home** button at top left of the screen. From there you can also access the project management and settings screens.

6.3 Project management

Using the functions accessed from the **Projects** submenu you can manage projects, display and analyze previously recorded scans and import new data.

6.4 Importing PS 1000 X-Scan projects and data

- Connect the PS 1000 X-Scan using the PSA 52 data cable.
- Press the **Import** function button and then select the PS 1000 X-Scan.
- Either use the check boxes to select one or more projects or tap a project to show the scans it contains. These scans can then also be selected by way of the check boxes.
- Confirm your selection by pressing the **OK** function button and, if individual scans have been selected (see point 3), then select the target project on the PSA 200 tablet.
- The selected objects (projects or individual scans) will then be imported.

6.5 Importing PS 200 S Ferrosan projects and data

- Insert the PSA 56 infrared adapter in a USB port on the PSA 200 tablet.
- Position the PS 200 S opposite the PSA 200 tablet so that the IR interfaces are facing each other directly.
- Press the **Import** function button and then select the PS 200 S.
- Select the project into which the scans from the PS 200 S are to be imported.
- All the scans from the PS 200 S will then be imported into the selected project on the PSA 200 tablet.

6.6 Importing PS 300 projects and data

1. Connect the PS 300 to the PSA 200 by means of the data cable.
2. Press the **Import** function button and then select the PS 300.
3. Either use the check boxes to select one or more projects or tap a project to show the scans it contains. These scans can then also be selected by way of the check boxes.
4. Confirm your selection by pressing the **OK** function button and, if individual scans have been selected (see point 4), then select the target project on the PSA 200 tablet.
 - ↳ The selected objects (projects or individual scans) will then be imported.
5. When finished, sever the connection between the PSA 200 and the PS 300 / PS 300-W.

6.7 Analyzing scans

1. Select the desired scan from a project.
 - ↳ The scan is then displayed.
2. Use the function button to set the display mode to **2D** or **3D**.
3. The **Param.** and **Visualization** function buttons can be used to change the visualization and calculation parameters. If you change the values in **Param.**, the data will have to be recalculated. To do this, press the **OK** confirmation button beside the parameter that has changed.
4. The **Extras** function button provides access to various functions including the ability to export simple reports in PDF format or to make and play back audio recordings.
5. You can use the **Drillhole** function button to show the drillholes in Imagescans or to define new drillholes.
6. The data from the PSA 200 tablet can be transferred to a PC for further analysis.

8 Care and maintenance



WARNING

Risk of injury with battery inserted !

- ▶ Always remove the battery before carrying out care and maintenance tasks!

Care and maintenance of the tool

- Carefully remove stubborn dirt.
- Clean the air vents carefully with a dry brush.
- Use only a slightly damp cloth to clean the casing. Do not use cleaning agents containing silicone as these can attack the plastic parts.

Care of the Li-ion batteries

- Keep the battery free from oil and grease.
- Use only a slightly damp cloth to clean the casing. Do not use cleaning agents containing silicone as these may attack the plastic parts.
- Avoid ingress of moisture.

Maintenance

- Check all visible parts and controls for signs of damage at regular intervals and make sure that they all function correctly.
- Do not operate the product if signs of damage are found or if parts malfunction. Have it repaired immediately by **Hilti Service**.
- After cleaning and maintenance, fit all guards or protective devices and check that they function correctly.



To help ensure safe and reliable operation, use only genuine Hilti spare parts and consumables. Spare parts, consumables and accessories approved by Hilti for use with the product can be found at your local **Hilti Store** or online at: www.hilti.group.

9 Transport and storage of cordless tools

Transport

 **CAUTION**

Accidental starting during transport !

- ▶ Always transport your products with the batteries removed!
- ▶ Remove the battery.
- ▶ Never transport batteries in bulk form (loose, unprotected).
- ▶ Check the tool and batteries for damage before use after long periods of transport.

Storage

 **CAUTION**

Accidental damage caused by defective or leaking batteries !

- ▶ Always store your products with the batteries removed!
- ▶ Store the tool and batteries in a place that is as cool and dry as possible.
- ▶ Never store batteries in direct sunlight, on heating units or behind a window pane.
- ▶ Store the tool and batteries in a place where they cannot be accessed by children or unauthorized persons.
- ▶ Check the tool and batteries for damage before use after long periods of storage.
